## Collection Overview

**Abstract:** The Sugg Family Collection contains scrapbooks, daybooks, photographs, photo albums, artifacts, and personal family papers collected by Mary Ann Sugg. The collection provides a look into the lives of the Sugg family from the late 1800s to the early 2000s, spanning three generations.

## Scope and Content

The Sugg Family Collection contains items relating to the Dr. John T. Sugg family and spans the period from the late 1800s to the early 2000s encompassing three generations. Records in this collection include Dr. John T. Sugg's daybooks for the years 1900 to 1903 and 1906 to 1908 where he recorded his daily activities as a doctor in rural Williamson County to the estate papers of John T. Sugg, Jr., family correspondence, educational records, photographs and more.

## Arrangement

This collection is organized around four main record series: Photographs, school diplomas and certificates, scrapbooks and daybooks, and estate papers. Several oversized framed objects have been left framed and stored together due to their size.

The records in this series were lightly curated by the director of the archives to keep similar records together.

## Historical Note

Dr. John T. Sugg came to Williamson County, Tennessee, from Dickson County in 1897. He settled in North Williamson County in Beechville, becoming the community doctor. Three years after arriving in Beechville, Dr. Sugg and his wife, Ella Hogan, purchased ten acres on Sneed Road. In 1902, they purchased an additional one hundred and forty-six acres directly across the Hillsboro Pike from the original ten acres on Sneed Road. Two sons, William Daniel and John Thomas, were born not long before the move to Sneed Road, and in 1905, their sister, Susie Caro, made them a family of five. Besides his medical profession, Dr. Sugg farmed the land. The family eventually added hogs, cattle, and dairy cows to their farm. In 1920, Dr. Sugg purchased additional acreage; the farm now totals two hundred twenty-five acres.

Beechville was very near to Nashville, and Dr. Sugg was easily able to travel back and forth, often attending seminars and classes to update his medical skills. His daybooks, located in this collection, evidence not only his trips to Nashville for training but also offer the reader an interesting glimpse into his “house calls,” visiting ailing residents, of which Dr. Sugg kept notes.

Ella Hogan Sugg suffered from tuberculosis and died in 1929. Dr. Sugg continued to serve as the local county doctor until his death in 1931. All three children of Dr. and Mrs. Sugg graduated from Battle Ground Academy as well as Vanderbilt University. First-born William Daniel became a doctor like his father and opened a practice in Bradenton, Manatee County, Florida. He married the former Ruth Dickinson. Dr. Sugg and his wife donated Carnton Plantation to the Carnton Association in 1978. Dr. Sugg died in 1981, and Mrs. Sugg died in 1998.

His brother, John T. Sugg, Jr., worked in finance in New York but later returned to Williamson County and worked for the Werthan Bag Company in Nashville. John T., Jr. lived on the family farm and expanded the dairy, naming it Harpeth Brook Dairy. He was married to the former Marian Mathews in 1927, and they were parents of two children, Dr. John T. Sugg, III, and Mary Ann Sugg. He passed away in 1982 and Marian Sugg in 1987.

Susie Caro Sugg spent her life as a schoolteacher, settling in Florida. She married Robert Piant in 1944. She passed away in 1973; her husband passed away in 1975.

The third generation of the Sugg family, Dr. John T. Sugg, III, and his sister, Mary Ann Sugg, continued the family tradition of graduating from Vanderbilt University. Dr. John T. Sugg, III, was a doctor in New York City and died in 2016. His sister Mary Ann, the compiler of this collection, spent a few years in New York as a social worker but eventually returned to Williamson County to care for her aging parents. She died in 2017.
