NOTICE TO APPELLANT(S)

Tennessee Code Annotated section 27-5-108 allows you to appeal the Judgment of the General Sessions Court by the filing of a *Notice of Appeal* within ten (10) days of entry of the General Sessions Judgment. The ten (10)-day period begins on the day following the entry of the General Sessions Judgment. The *Notice of Appeal* must be filed by the close of business on the tenth (10th) day (e.g., where entry of a Judgment occurs on the 1st day of the month, the *Notice of Appeal* must be filed by the close of business on the 11th day of the month). If the last day of the ten (10)-day period falls on a Saturday, Sunday, or legal holiday, the *Notice of Appeal* must be filed by the close of business on the next business day.
