Individuals who intend to run as an independent candidate must file qualifying petitions by the December qualifying deadline along with all March primary candidates in order for their names to appear on the August 1, 2024, County General election ballot as an independent. **Non-nationally recognized candidates who intend to run in the Presidential Preference Primary have different qualifying dates for the election, please contact our office for those dates.
